Transferring A Membership: Transferring a membership is subject to Beehive approval.

### Member's Right to Cancellation:

You may cancel this contract without any penalty or further obligation by causing a written notice of your cancellation to be delivered by postmarked certified U.S. mail within 30 days of this contract or the date of receipt to the address specified in this contract. A refund will be given in fifteen (15) days. All checks are distributed on a 30 day cycle.

After a 30 day period, membership may be cancelled, and a prorated payment refunded, under one of the following circumstances :

- 1. The membership buyer becomes significantly physically or mentally ill for a period in excess of three months with reasonable evidence of illness including a Doctor's letter.
2. The membership buyer is also entitled to a prorated refund in the case of his/her death.
3. The membership buyer may also cancel their membership if he/she moves their residence 20 miles outside of NYC.

### Freezing a Membership:

A membership may be "frozen" for a period up to six months for reasons such as personal, business, vacation, illness or otherwise.
